

- 13. Mr HUI opined that deliberation on the policy issues of the Bill had been prolonged by the pro-establishment camp, and the Chairman's decision of not setting a timetable was in effect a form of filibuster.
- 14. **Mr HUI** questioned the Administration's determination to have the Bill passed within the current legislative session. He asked whether the Administration had requested the Chairman to convene meetings more frequently with a view to expediting the Bills Committee's work.

- 1. Mr TAM and **Mr HUI** requested the Administration to:
  - (a) clarify the policy objectives of tightening the emission standards for diesel private cars, and whether the objectives included controlling the number of diesel private cars, discouraging members of the public from purchasing diesel private cars, and containing overall vehicle growth in Hong Kong;
  - (b) with analysis of the major arguments in the international context which were respectively in favour of and against the use of diesel private cars, explain why it was justified to adopt the more stringent California LEV III standards instead of Euro VI for these vehicles in Hong Kong; and
  - (c) advise whether it would consider adopting a different set of emission standards for diesel private cars, or imposing a statutory ban on new registration of these vehicles in Hong Kong, if it was found that the emission performance of California LEV III-compliant diesel private cars in real-world driving was not superior to that of their Euro VI counterparts.

- 9. **Mr HUI**'s proposed amendment to section 9(3) of the REE Regulation to the effect of requiring registered suppliers of regulated electrical equipment ("REE") to affix recycling labels onto REE distributed by them, and deletion of section 27(3) which concerned how the recycling labels should be provided by sellers to consumers (LC Paper No. CB(1)1102/16-17(03)).
- 10. **Mr HUI** considered that sellers might discuss with registered suppliers with a view to making mutually agreed arrangements to fulfil their respective legal obligations in the provision of recycling labels for REE. He also indicated that he might review his proposed amendments and move the amendments in his name.
- 11. **Mr HUI** expressed concern that the words "or otherwise" in the proposed amendments to sections 9(3) and 27(3) (in respect of the duties of registered suppliers and sellers to provide recycling labels) might be construed as allowing registered suppliers and sellers to choose not to provide any recycling label at all.
- 12. **Mr HUI** opined that the proposed amendments to section 40 (to the effect of shortening the lead time for a consumer to consider a REE removal service) would undermine protection of consumers' right to make use of the REE removal service. He indicated that he might consider moving amendments in his name to enable a consumer to decide on the need of a removal service not later than his/her taking actual possession of the REE item concerned.
